2	Haifa	\$1,012	This 50 year old divorced mother of a 10 year old child lost her job as a caretaker and has been unemployed for two months. She has now found an even better job that will begin in April. The time of unemployment has	\$706

			caused her to fall behind in rent and utility payments that require immediate payment. This gift will help to bridge the gap until she receives her first new salary at the end of April.	
2	Haifa	nil	This husband of this 35 year old mother of a young child abandoned his family and returned to the Ukraine. After an extended search for work to replace his lost support she will begin work as a nurse assistant in April. This gift will help her cover basic living expenses until she can rebuild her new life.	\$618
2	Maalot	\$651	This 57 year old divorced 100% disabled woman provides limited support to her recovering drug addicted, unemployable 26 year old son who lives with her. Hence, both of them marginally survive on her small government stipend. She is unable to work and must have some medicines that are not otherwise provided. This gift is for food and for help with her medications.	\$324
1	Kiryat Bialik	\$1,339	This 71 year old widow was forced to move from her furnished apartment that was taken over by her landlord at the end of her lease. All she could find and afford was a totally unfurnished replacement apartment causing her to desperately seek bare essential furnishings she has no means to purchase. This gift will provide her with a refrigerator.	\$794

2	Beer Sheva	\$538	This recently divorced 59 year old mother of an unemployed 29 year old son is not yet receiving any support from her former husband and is unable to survive on the small help from the government she has just stated to receive. Thus, she has been unable to pay her utilities and her electricity is about to be terminated. This gift will avert this pending crisis.	\$412
1	Beer Sheva	nil	This 44 year old drug addicted man is under treatment at a Christian rehabilitation center that provides all of his basic needs but has no funding for dental treatment. Those few teeth he still has are decayed and causing him constant pain. This gift will alleviate this most immediate desperate situation.	\$515

7	Ashkelon	\$992	This 38 year old mother of five close in age young children was surviving on alimony payment from the government on behalf of her alcoholic former husband and her own modest salary as a part time house cleaner. The couple recently tried to reconcile. He moved back in—the alimony was immediately terminated. He move back out after two months and she is now waiting for reinstatement of the alimony payment. In the meantime, she is unable to pay her electric bill and these services are about to be terminated. This gift will help bridge the gap by paying this bill.	\$765
5	Ashdod	\$1,650	Both parents of three young children are in their early thirties and marginally employed, but their combined income leaves no room for dental care which has been deferred for many years and has now become a critical need for the mother who is suffering and in constant pain. This gift will provide for her most immediately needed care.	\$853
3	Ashdod	\$1,266	This 45 year old widow with two young children must move from her apartment that has just been sold by her landlord. She has located a new apartment but cannot afford either moving expenses of the required advance rent payment on her otherwise survivable income from the government and part time work. This gift will help her meet these relocation needs.	\$853

3	Ashdod	\$1,700	This couple nearing retirement were surviving well on their combined incomes until recently when the husband was diagnosed with stomach cancer and will likely never return to work. They have applied for government assistance which will likely eventually be granted but in the interim they are unable to survive on just the one remaining salary. This gift will help meet their immediate needs by paying one month's rent.	\$765
1	Ashdod	\$1,558	This 50 year old divorced woman is employed part time as a dentist in a local clinic. She recently became the subject of apparent religious persecution by persons unknown who set fire to her apartment door which must be replaced. However, she is also being pressed by the local	\$441

			authorities to pay for smoke damage to the rest of the building. She has no insurance to cover any of this expense. This gift will pay for the new door while she officially protests the demand that she pay for the remaining damage.	
2	Haifa	\$1,700	The husband of this couple in their early fifties is a former Professor from Brazil where he held a prestigious university teaching position. He is fluent in four languages and is struggled for four years to become proficient enough in Hebrew to teach in Israel but to his intense disappointment he failed in this and thus fell into a deep depression that led him to attempt suicide because he was unable to support his wife and himself at more than a bare survival level. Accordingly, the government declared him 100% disabled. Even so, with his government assistance and his wife's very small part time earnings they have still fallen deeply in debt and he remains utterly despondent. This gift will be used to meet their most immediate needs and to offer them the encouragement that there are those who care deeply while he continues to gain fluency in Hebrew.	\$1,235
