I certainly have had a lesson about pride during the past two months. I was genuinely puffed up by the great gift of \$3,000 from one of our most generous congregations during our recent visit to the States. Then, I was equally excited by two unusually large "love offerings" from other highly supportive congregations. Top this off with your more than usually generous "regular" donations and there I was, going into our recent Board meeting with more than \$11,000 available for distribution to our most hurting immigrants who were struggling to survive here in the Land of our inheritance, convinced that we would be able meet all requested needs and still have a carry over for next month.

Wow! What a lesson---I am still reeling from the 26 legitimate requests for assistance we reviewed and the fact we could only fund 19 of these, and at that could, in most cases only provide band-aide fixes; that is partial solutions. You will see this reflected in the attached report where our average gift was around 2,000 NIS (\$571) when, in most cases, 3,000-4,000 NIS was needed to completely resolve most of these often heart rending issues set before us.

I guess my point is, we all need to rejoice that through your even more than faithful giving and our team's dedicated efforts, together we have, by the grace of God, managed to greatly touch the lives of literally dozens of hurting brothers and sisters represented in these 19 recipient families scattered from one end of the Land to the other.

Surely, this is a call to us all to be thankful, joyful and genuinely blessed that we have been called to this urgent outreach.

May the Lord God of Israel greatly bless each of you at this Holy season of great celebration.
