Shalom Dear donors and friends of the Olim Fund of the Land of Israel,

This has been a relatively quiet month here in the Land, as our people are slowly but surely getting back to "normal" after our summer war with Hezbollah.

The effects of the war, however, are still impacting our olim families as you can see from the several needs we were able to fund this month that were directly related to family level finances. I feel certain that we will continue to see additional such requests over the coming months, probably well into the new year.

Our total distributions are down a bit this month. There are two basic reasons. First, our Board was not totally satisfied with the administrative quality of some of the applications we received this month in the light of our recent and ongoing emphasis to our representatives that we required clear documentation and explanation with each request for assistance. To make our point, we consequently rejected more requests than usual, asking that they be resubmitted under the tutorial guidance of Yakov Dolinsky, who is our interface with the organizational representatives. We anticipate this will generate an improvement in this regard over the coming months. We take very seriously our fiduciary responsibility to each and every donor to make certain that every donated dollar flows is used to satisfy the most urgent of the many requirements that come to our attention.

The second reason for our relatively low total distribution this month is that we had an inordinately high number (five) of referrals to our three associated dental clinics. These will be funded over the next two or three months. Our dental program has been a very satisfying outreach for all concerned. We are praying that our donation base will increase sufficiently for us to expand this program to other cities until eventually we have an associated clinic in every major city in Israel. I'm sure that there are few among us who have not experienced the pain of a toothache. I can't imagine how terrible it would be to have no way to resolve this unhappy common human experience---especially as it is experienced by so many of our olim children whose parents simply cannot afford to pay for dental care.

Once again, on behalf of our Board of Directors and even more, on behalf of all the many who your faithfulness and concern have helped to survive here in the land to which they have been called, our deep and profound thanks.
